In case the mission cannot guarantee settling of dues, the candidate will get one permanent member of the Islamabad Club as a proposer.

5. Applications for diplomatic membership will be forwarded to the Administrator Islamabad Club for approval after being duly recommended by the Secretary Islamabad Club.
