TERMS & CONDITIONS:

- 1. The supplier must be registered with Federal Board of Revenue (FBR) for Income / Sales Tax and should be on active tax payers' list. Quoted prices must include all applicable taxes.
- 2. Maintenance, upgrading and operating the software of the electronic scoreboard during matches/events as and when required.
- 3. The Vendor shall provide a dedicated resource for operating the software and maintenance of the software.
- 4. The Vendor shall send their operator 02 hours prior to the starting of the match or an event.
- 5. In case of non compliance of conditions, a penalty equal to 25% of the match charges shall be deducted.
- 6. The Vendor shall be responsible for the execution of minor errors, bugs, and adjustments / changes if and when required.
- 7. The Vendor must notify, in writing, to the client prior to the making of any adjustment / changes.
- 8. All employees and persons of the vendor providing any services must comply with all security regulations of the client. No entrance to the Club premises or any of its parts thereof will be allowed without prior approval by the client.
- 9. The Vendor shall be liable to resolve the issues with the scoreboard software within 24 hours of being notified by the Client
- 10. Bid must be for 90 days from the opening date of the tender.

- 11. Interested parties should submit their sealed bids along with complete profile which contain detail of completed projects & completion reports.
- 12. Bidders must have relevant experience of at least 5 years.
- 13. Bidder who have supplied and installed electronic scoreboards in cricket grounds will be preferred.
- 14. Tender documents will be received in the Club at 03:00 pm and will be opened publicly on the same day at 03:30 pm. In case of gazette holiday(s) falling on the date of tender opening, tender will be opened at the same time on the next working day. It will be the responsibility of the bidder to deliver the bids at the closing time. Islamabad Club does not take any responsibility whatsoever for collection of the bids from any bidder. You or your authorized agent shall attend the tender opening. Tender received after the time specified for submission shall not be accepted.
- 15. You are required to clearly mention, in your bid if any item(s) of your bid is/are exempt from tax.
- 16. Bids must accompany a bid security @ 5% of the total bid value (including all taxes) in the form of bank draft/pay order in favor of Islamabad Club which is refundable. (Islamabad Club NTN: 6470486-8)
- 17. Bid, without the bid security of having lesser amount of security as mentioned above, will be treated as non responsive and will not be considered at the time of bid opening.
