5. **No pre-bid meeting will be held.**
6. **Site Visit:** Potential bidders may visit the site **on any working day before the bid submission deadline between 10:00 Hrs to 16:00 Hrs**, after prior coordination.
7. All technical and contractual clarifications must be sought **in writing** via the EPADS messaging system or email to the Procurement Department.
8. **Bid Submission Method:** Bids must be submitted **electronically through the EPADS system** only. Physical submissions are not allowed.
9. **Bid Security:** All bids must be accompanied by a **Bid Security of PKR 100,000/-** in the form of a **Pay Order / Demand Draft / Bank Guarantee** from a scheduled bank, valid for **120 days**, in favor of **Islamabad Club**.
10. **Award Criteria:** The contract shall be awarded to the bidder who:

PART 2 – INSTRUCTIONS TO BIDDERS (ITB)

2.1 Eligibility Criteria

Bidders must meet the following **Mandatory Eligibility Criteria (MEC)** at bid submission:

1. **Tax Status:** Valid **NTN & Sales Tax Registration (STRN)** and appearing on **Active Taxpayer List (ATL)** of FBR.
2. **Non-Blacklisting:** Duly signed **Affidavit on Rs. 100/- Judicial Stamp Paper** declaring non-blacklisting.
3. **Experience:** Minimum **03 years** experience in civil works/pavers/landscaping projects.
4. **Similar Projects:** Completion of **at least two (2)** similar paver/civil works projects of value \geq PKR 2.0 million in last 3 years.
5. **Bid Security:** Submission of Bid Security of **PKR 100,000/-**.
6. **PEC Registration:** Valid Pakistan Engineering Council (PEC) registration.

2.2 Language & Currency

Bid documents must be in **English**. Prices in **Pakistani Rupees (PKR)**, inclusive of all taxes.

2.3 Bid Validity

Bids shall remain valid for **120 days** from bid opening.

2.4 Sealing and Marking

Two Envelope Procedure:

- **Envelope-1 (Technical Proposal):** All technical, eligibility, qualification documents. **No financial information.**
- **Envelope-2 (Financial Proposal):** Only priced BOQ, Form of Bid, Price Summary, and original Bid Security.

2.5 Deadline for Submission

Bids must be submitted by **11:30 Hrs on January 23, 2026**. Late bids will be rejected.

2.6 Bid Opening

Technical bids opened first. Financial bids of only technically qualified bidders opened later on notified date.

PART 4 – TECHNICAL SPECIFICATIONS & SCOPE OF WORK

4.1 Scope of Work

Complete execution of all civil works including but not limited to:

- Excavation, leveling, compaction, backfilling
- Supply and laying of PCC (1:4:8, 1:2:4, 1:3:6)
- Supply and fixing of concrete tuff pavers (100x200x60mm, min. 5000 psi)
- Supply and fixing of concrete vibratory tiles (12"x12"x1.25")
- Supply and laying of precast kerb stones (12"x12"x6") with PCC haunching
- All works as per attached BOQs and Engineer's direction

4.2 Technical Specifications

4.2.1 Earthwork & Compaction

- Excavation as per required depth, removal of surplus soil
- Compaction to achieve 90% modified dry density
- Gravel mix backfilling in layers not exceeding 6 inches

4.2.2 Concrete Works

- **PCC 1:4:8:** 3" thick, OPC, leveling and curing
- **PCC 1:2:4:** 4" thick, min. 2175 psi at 28 days
- **PCC 1:3:6:** 3" thick, min. 1450 psi at 28 days
- Use of Lawrencepur sand and 1/2" down crushed aggregate as specified

4.2.3 Pavers & Kerb Stones

- **Concrete Tuff Pavers:** 60mm thick, 100x200mm, grey/red, min. 5000 psi crushing strength, machine finished
- **Concrete Vibratory Tiles:** 1.25" thick, 12"x12", red & grey
- **Kerb Stones:** 12"x12"x6", precast fair-faced, fixed with 1:4 cement sand mortar and 75mm thick 1:3:6 PCC bed/haunching

4.2.4 Installation

- Fixing of pavers/tiles with 1:4 cement sand mortar and sand filling
- Proper interlocking, leveling, and joint filling as per approved design
- All works to be completed under the direction of the Engineer In-charge

4.3 Special Requirements

- i. **Quality Assurance:** All materials must be as per approved samples and standards.
- ii. **Warranty:** 12-month defect liability period for all works.
- iii. **Completion Time:** Maximum 45 days from issuance of work order.
- iv. **Site Restoration:** Contractor shall restore any disturbed areas to original condition.

v. **Safety:** Adherence to all safety protocols and protection of existing utilities.

PART 5 – GENERAL CONDITIONS OF CONTRACT (GCC)

5.1 Governing Law

Governed by laws of Pakistan and PPRA Rules, 2004.

5.2 Performance Security

The Bid Security submitted by the successful bidder shall be retained as the Performance Security. It shall be released after satisfactory completion, testing, and handover of works.

5.3 Time for Completion

Maximum **45 calendar days** from Letter to Proceed.

5.4 Liquidated Damages

0.1% of contract price per day delay, maximum 10%.

5.5 Defect Liability Period

12 months from completion certificate.

5.6 Payments

Payment shall be released upon submission of a valid invoice after successful completion, verification, and certification by the Club's Engineering Department, and after deduction of applicable taxes.

5.7 Termination

As per PPRA rules for default, insolvency, or corrupt practices.
